Consider taking a moment and phoning a fellow pensioner, or older friend or neighbor. Your call might be the highlight of their day.



President's News Letter June 19, 2020.

Greetings from the National Council of Canadian Pacific Pensioners Associations (NCCPPA). In accordance with the NCCPPA by laws article VIII Section 1, I am here by submitting my first activities report of 2020. In addition to the continuation of some of the past initiatives, below I have listed some activities that we have undertaken.

- In collaboration with Perkopolis Account Manager and CP Pensioners Associations Windsor Ontario, steer the processes of issuing individual registration/log in codes to members of CP Pensioners Association Windsor. Once Windsor is completed Revelstoke Association would be the next. The members of the executive committee at the CP Pensioners Association Medicine Hat, Alberta have decided not to enroll with Perkopolis Discount Program.
- On March 3, 2020 Bob Cameron, Lyle Berge and I held a meeting with Blain MacIsaac, Director Pension Services and Kathleen Boucher, Manager Pension Services. We discussed to include the English/French copies of the new Pensioners Brochures with the pension application packages along with the updated contact list of the NCCPPA local chapters. The old contact list was certainly outdated. Lastly, we requested for the list of pensioners who have provided CP with their consents to sharing their contacts with the Pensioners Associations. I must add that this was a very productive meeting.
- Distributed to the NCCPPA chapters the list of the local pensioners who have provided consents. The officers at the local chapters should contact non member pensioners in their respective areas to informing them about their association's contacts, membership processes and activities as well as programs. Since the last few years, NCCPPA were never given these lists, however, going forward, I have requested CP to render every quarter the list of all new pensioners who have given their consents.
- Lyle has posted the new pensioners brochures on cp-pensioners.com under header "About". Please have a read. Once the pandemic is over printed copies will be provided to CP Pension Services to include with non-electronic pension application packages.

CP has a gradual return to work plan for various working groups. Other than essential front line workers, most of the employees are currently working from homes. As you are aware that due to the Covid-19 restrictions and lock downs, we had to cancel our May 22 & 23, 2020 NCCPPA Triennial Convention in London Ontario. Once things are normal and approval is given by the health authorities, we will ask all stake holders for rescheduling of the Convention.
