Report to Manitoba Chapter, NCCPPA September 11, 2025

Dear Manitoba Chapter Members,

As your delegate to the NCCPPA Triannual Convention (June 6-7, 2025, Glenmore Inn, Calgary), I'm pleased to report on key outcomes and my election as NCCPPA President for a three-year term starting September 1, 2025.

The Calgary Chapter, led by Joe Dragani, hosted a productive event, with tours of CPKC facilities and a presentation by Blain MacIsaac, Director of Pension Services.

The 2022 minutes were approved, and old business included keeping In Memoriam on the CP Pensioners webpage and rejecting Rae Leduc's restructuring resolution due to limited executive capacity. Discussions noted CN's 3400 members versus our 700, highlighting their dues checkoff system.

Manitoba's ten resolutions shaped the agenda: setting the next convention for June 1-2, 2028 (Resolution 1); enabling webinar meetings (Resolution 2); transitioning to email newsletters (Resolution 3); creating a social media policy (Resolution 4); adding NCCPPA information to pension statements (Resolution 5); advocating for HSA inflation protection (Resolution 6); raising the COLA cap to \$3000 (Resolution 7); enhancing union ties (Resolution 8); reviewing consent lists for recruitment (Resolution 9); and pursuing dues checkoff (Resolution 10). All were approved or actioned.

Calgary and Revelstoke resolutions aligned where feasible, though some (e.g., Blue Cross increases) were rejected per CPKC's stance. A \$3,500 monthly Pension Rep stipend was approved.

Bylaws updates included mileage (72 cents/km), per diem (\$75), and honorarium (\$600).

The new executive includes Manitoba's Lou Guay (Secretary). Our priorities include dues checkoff, union collaboration, and membership growth.

Your support is vital as we advance.
